I. Call to Order:

Chairman Whitfield called to order the Public Hearing held at Walker County Annex III, 201 S Main Street, LaFayette, Georgia at 6:30 PM on August 12, 2021.

III. Public Hearing:

Chairman Whitfield stated this is the second public hearing on the adoption of the millage rate and added the third will be later this month. Chairman Whitfield stated this will be the lowest millage rate the county has had in the past four years. He said the county has been working to lower the millage rate every year. He said this is a partial rollback but due to the state formula if there are any additional revenues compared to the previous year then it has to be advertised as a tax increase. He added the additional revenues are from sales taxes and the majority of them are from an increase in online sales and citizens shopping locally due to COVID19. He added the 2018 TSPLOST is included in the sales tax. Chairman Whitfield stated the recent assessment notices that were sent out by the Tax Assessor use the previous years millage rate which is higher than the new millage rate. He said when the tax bills go out in October they will have the new millage rate on them and they should be less than the assessment notices. Chairman Whitfield asked if anyone from the public would like to come forward with any questions, there were none.

City, hungry for a new life and her strong-willed husband, Tom Buchanan. It’s there that he reconnects with his kind cousin, Daisy, who begins to learn more about

his mysterious and generous neighbor, a wealthy man

named Gatsby who seems to have it all.

As Nick and Gatsby formed an unlikely friendship, he learns that Gatsby is a long-lost love of Daisy, who is still married to Tom... and that Gatsby has built up his enormous fortune as part of a plan to win Daisy back at all costs.

Considered to be F. Scott Fitzgerald’s best work, “The Great Gatsby” examines America at the peak of the Jazz Age, exploring what the American Dream truly represents and its ultimate impracticality.

“The Great Gatsby captures so much of the American Spirit, both the inspiring and the bleak,” Director Madison Smith said. “There was such a hunger in the new advanced world of the 1920s to taste all the promises of life: money, love, success and prosperity.”

“After years of death and destruction, the general feeling of that time was that American prosperity had finally been set free.

“Anyone could become anything if they just worked hard enough,” Smith said. But, from Fitzgerald’s point of view, all these promises were at best evasive, and at worst a dangerous delusion.”

Smith says “The Great Gatsby” has stood the test of time because it appeals to the universal American experience that is stronger today, nearly 100 years later. “Even today we’re told: if you just work a little harder, reach out your arms just a little further, you can rise out of your circumstances and thrive,” she notes.

“That’s the national ethos that’s driven this country, for better or worse, since the beginning, and the crux of “The Great Gatsby.”

The production is complete with hallmarks of the 1920s, from flappers to the Charleston, drinks and parties, the experience will be transformative.

“The Jazz Age is romantic and tantalizing,” Smith said. “So much possibility, so many people to meet, so much potential. Gatsby represents that idea: someone from less than nothing, overcoming all obstacles to get to where and who he wants. But Fitzgerald was ultimately cynical about these beliefs. He spotlights the American reality of classism, limitations of status and circumstance, and the duality of prosperity and poverty living within the same America.”

NOTICE OF PROPERTY TAX INCREASE

The Governing Authority of Walker County, Georgia has tentatively adopted a millage rate which will require an increase in property taxes by 3.26% in the unincorporated area and 0.54% in the incorporated areas.

All concerned citizens are invited to public hearings on this tax increase to be held at the Walker County Civic Center, 10052 Hwy 27, Rock Spring, GA on August 12, 2021 at 8:00 a.m. and at Walker County Courthouse Annex III, 201 S Main St., LaFayette, GA on August 12, 2021 at 6:30 p.m.

Time and places of additional public hearings on this tax increase are at Walker County Courthouse Annex III, 201 S Main St., LaFayette, GA on August 26, 2021 at 7:00 p.m.

This tentative increase will result in a millage rate of 8.313 mills in the unincorporated area and 11.963 in the incorporated areas, an increase of 0.259 mills in the unincorporated area and 0.065 mills in the incorporated areas. Without this tentative tax increase, the millage rate will be no more than 8.054 mills in the unincorporated area and 11.898 in the incorporated areas. The proposed tax increase for a home with a fair market value of \$125,000 is approximately \$12.43 in the unincorporated area and \$3.12 in the incorporated area and the proposed tax increase for nonhomestead property with a fair market value of \$75,000 is approximately \$7.77 in the unincorporated area and \$1.95 in the incorporated areas.

Explore role of sharpshooters in Battle of Chickamauga

On Saturday, Aug. 7, at 2 p.m., Chickamauga and Chattanooga National Military Park will present a special 90-minute, ranger-led car caravan tour exploring the role of sharpshooters during the Battle of Chickamauga. This program begins at the Chickamauga Battlefield Visitor Center.

What was the role of sharpshooters during the Civil War? Americans had long made their ability with rifles a matter of national pride and myth; therefore, when the Civil War erupted, experts on both sides decided that specialized sharpshooter

units would be required in the field. These units, many of which had special training and weapons, considered themselves elite units, though not all were.
