Executive Session

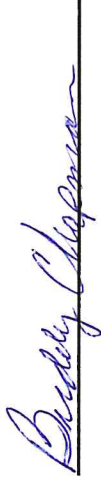

Mrs. Powell made a motion to end executive session at 10:43 A.M.; Ms. Deck made a second to the motion. The motion passed unanimously.

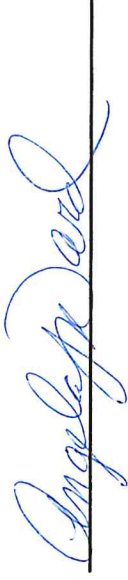
Ms. Deck made a motion to adjourn the meeting; Mrs. Powell made a second to the motion and the motion passed unanimously.
